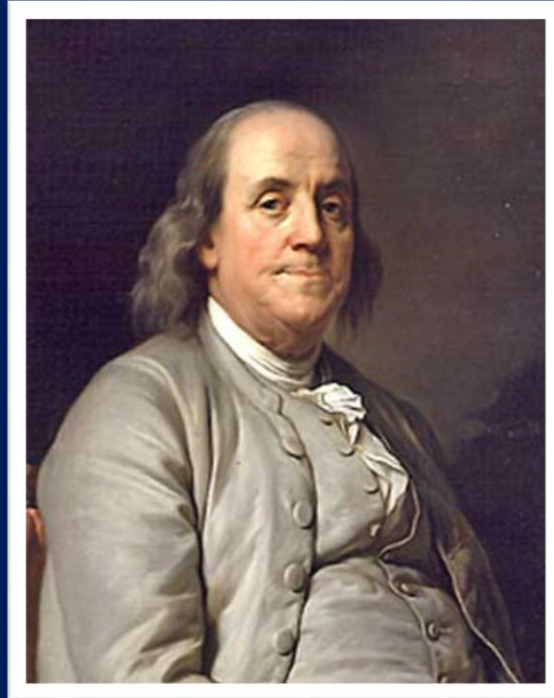

Benjamin Franklin

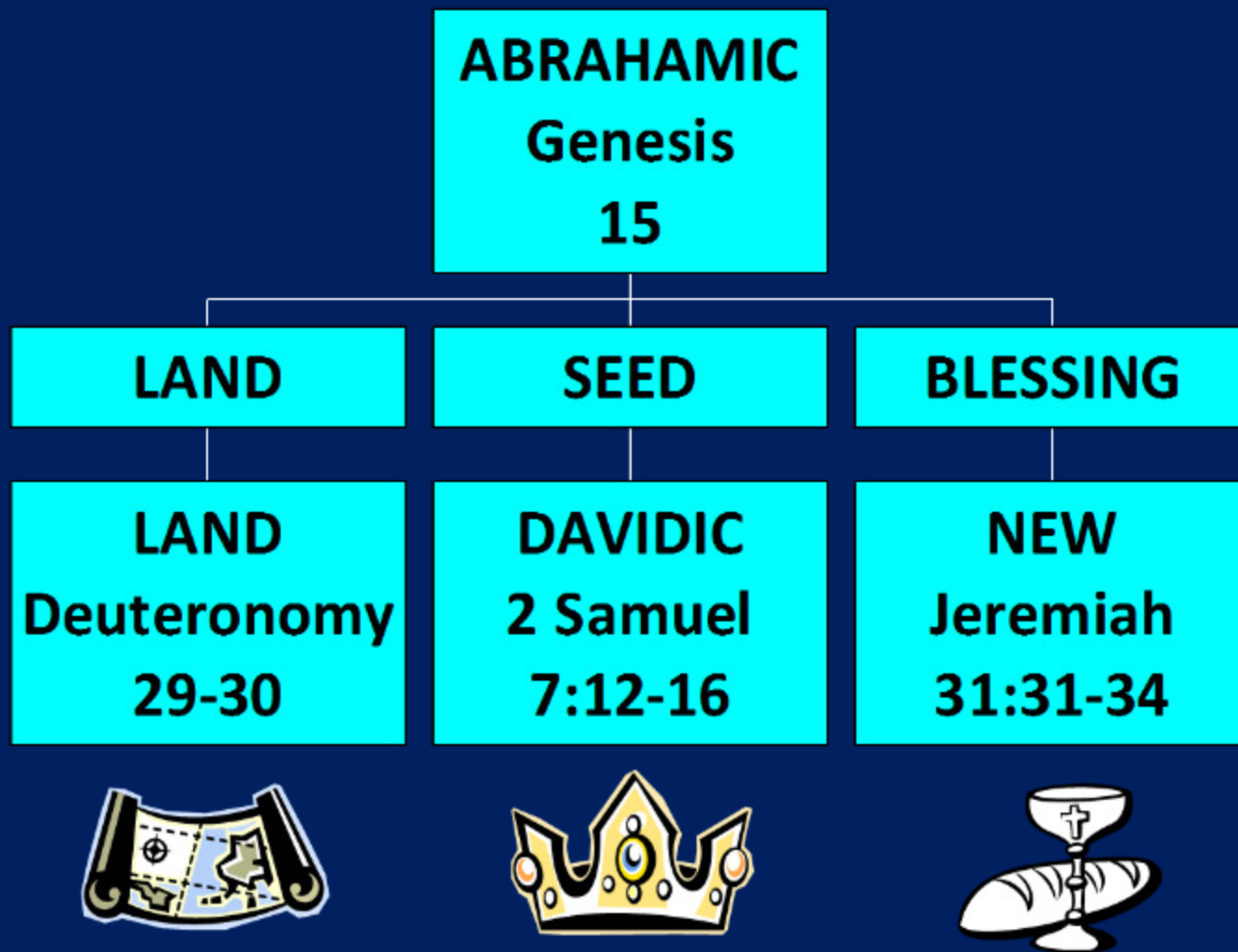

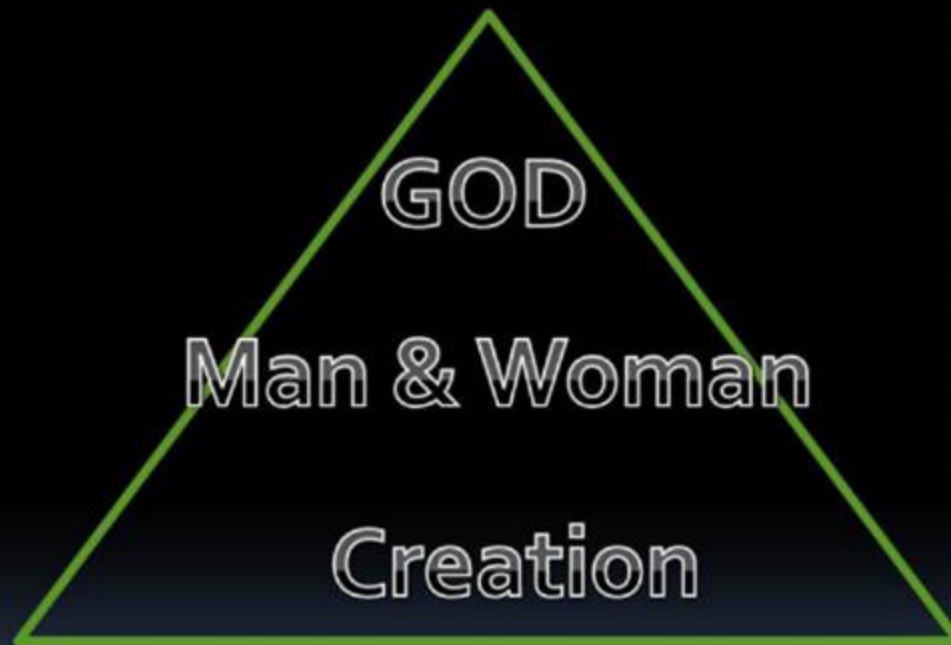

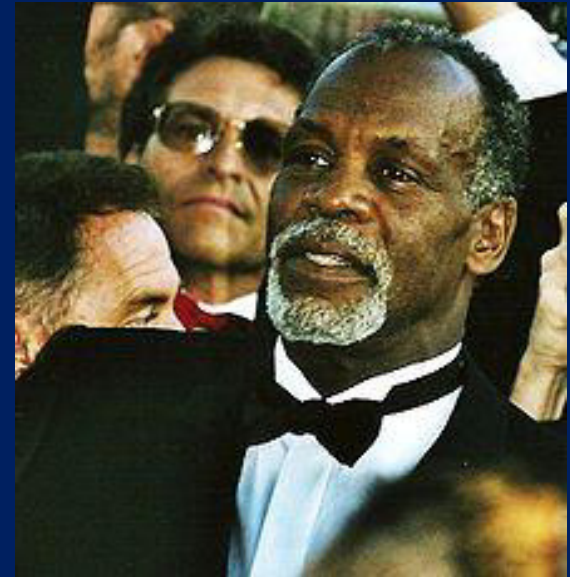


Gaia Hypothesis

“Gaia is Mother Earth. Gaia is immortal. She is the eternal source of life. She does not need to reproduce herself as she is immortal. She is certainly the mother of us all, including Jesus...Gaia is not a tolerant mother. She is rigid and inflexible, ruthless in the destruction of whoever transgresses. Her unconscious objective is that of maintaining a world adapted to life. If we men hinder this objective we will be eliminated without pity.”

Gaia Hypothesis

Remarks on Climate Change

“When I think about the array of...global threats –... terrorism, epidemics, poverty, the proliferation of weapons of mass destruction – all challenges that know no borders – the reality is that climate change ranks right up there with every single one of them...Or think about the proliferation of weapons of mass destruction. It doesn’t keep us safe if the United States secures its nuclear arsenal, while other countries fail to prevent theirs from falling into the hands of terrorists...”
