“A third observation is that there are no gaps in the genealogy. Some try to put gaps into the genealogy in order to accommodate the scientific long age of man, but the wording does not allow for that. If the text only said begat, then that would be permissible since the word ‘begat’ does not always require direct father/son relationship. It could mean grandfather, great grandfather, or ancestors and so on. Nevertheless, the wording in this section does not allow for that interpretation. The text does not say simply begat. It gives the years before and after the birth of the seed-son. So this type of language simply does not allow gaps to occur.”

Genealogical Gaps?



- Matthew 1:1-17?
 - ◆ Matt 1:8-9; 1 Chr 3:10-12
 - ◆ Larger portion of history
 - ◆ Age of father at the time the son is born
 - ◆ Matt 1:17 (3 groups of 14)
 - ◆ *Gematria* (sum of Hebrew letters in David's name adds up to 14)

Matthew's Purposes

- Earliest Gospel written to Hebrew-Christians
- To explain that Jesus in whom they had believed was indeed the long-awaited **Jewish Messiah**
- To explain why the kingdom had been **postponed** despite the fact that the king had arrived
- To explain the **interim program** of God during the kingdom's absence

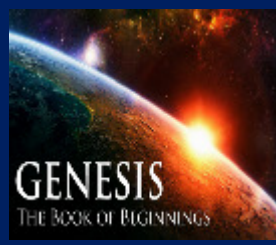

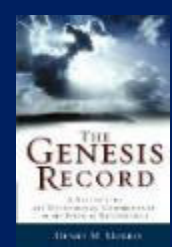

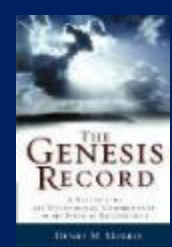


“If it is further assumed that, on the average, these children grew to maturity, married, and began to have children of their own by the time their parents were eighty years old, and that the parents lived through an average of five such ‘generations,’ or four hundred years, then it can easily be calculated that the earth had acquired within its first eight hundred years (presumably approximately the lifetime of Cain, as a minimum) a population of at least one hundred and twenty thousand. It is probable that the figure was much more than this, since people lived to greater ages than assumed and probably had many more children than assumed.”

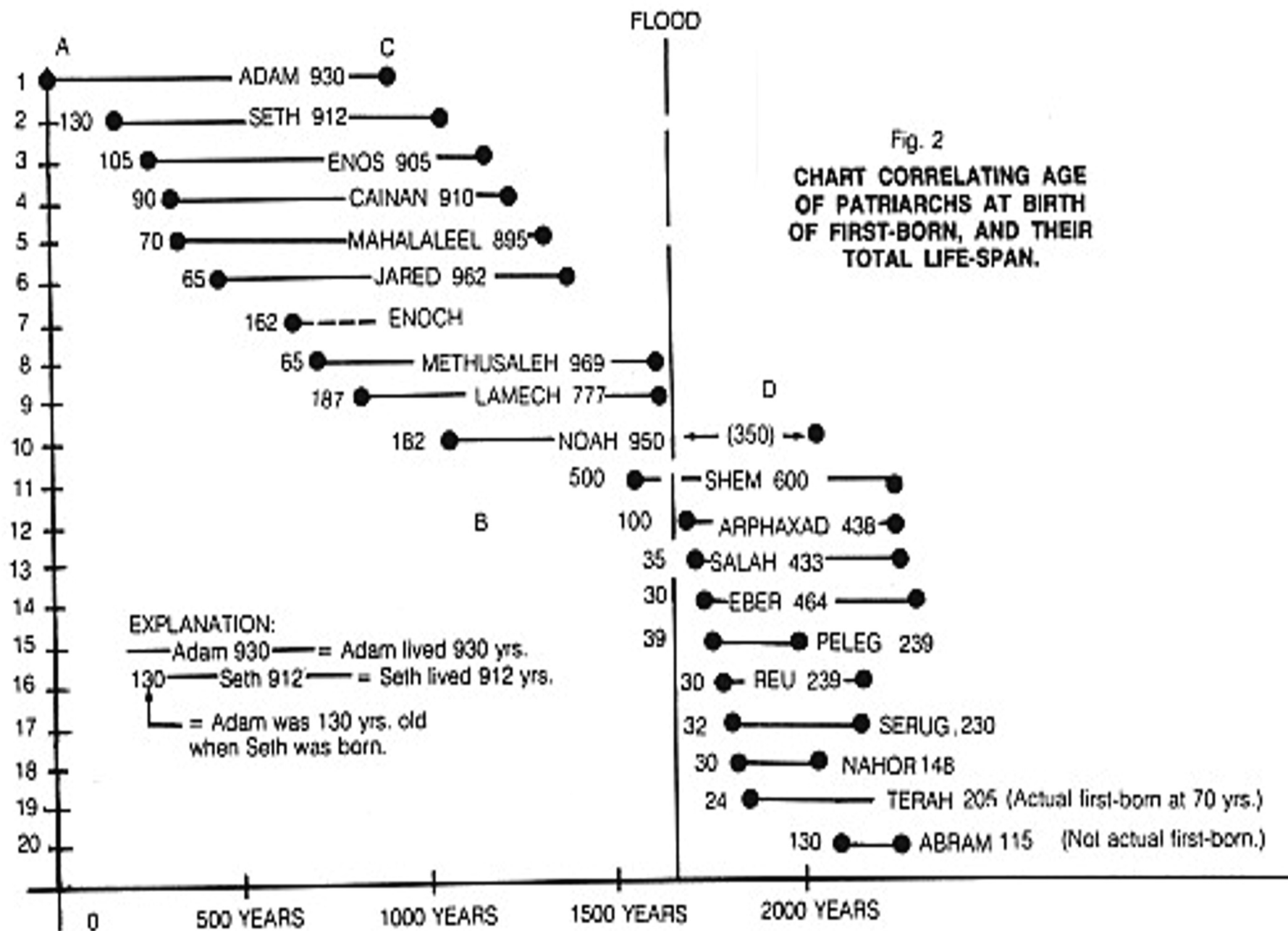


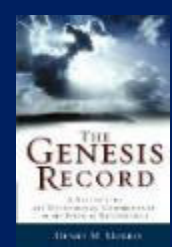
Day 2 Canopy Theory

“...the upper waters would provide a sort of protective canopy (‘a tent to dwell in’) for earth’s inhabitants, and the space between would provide an atmospheric reservoir to maintain the breath of life...The ‘waters above the firmament’ thus probably constituted a vast blanket of water vapor above the troposphere and possibly above the stratosphere as well, in the high-temperature region now known as the ionosphere, and extending far into space. They could not have been the clouds of water...there was no ‘rain upon the earth’ in those days (Genesis 2:5), nor any ‘bow in the cloud’ (Genesis 9:13), both of which must have been present if these upper waters represented merely the regime of clouds which functions in the present hydrologic economy.”

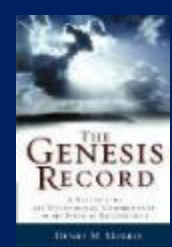

Since this name means ‘substitute,’ it is apparent that God meant Seth to be a substitute for Abel. (H. C. Leupold, *Exposition of Genesis*, p. 226). 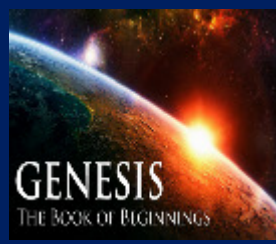


“Then comes the break from the norm. In Genesis 5:29, Lamech names his seed-son: He called his name Noah: saying, This same shall comfort us. The Hebrew word for comfort is *nacham*; hence, Noah means “comfort.” Here again is a word play that only works in Hebrew. The name was given on the assumption that Noah was the Seed of the Woman or the Messiah: This same shall comfort us in our work and in the toil of our hands, which comes because of the ground which Jehovah had cursed, in reference to the Adamic curse.”

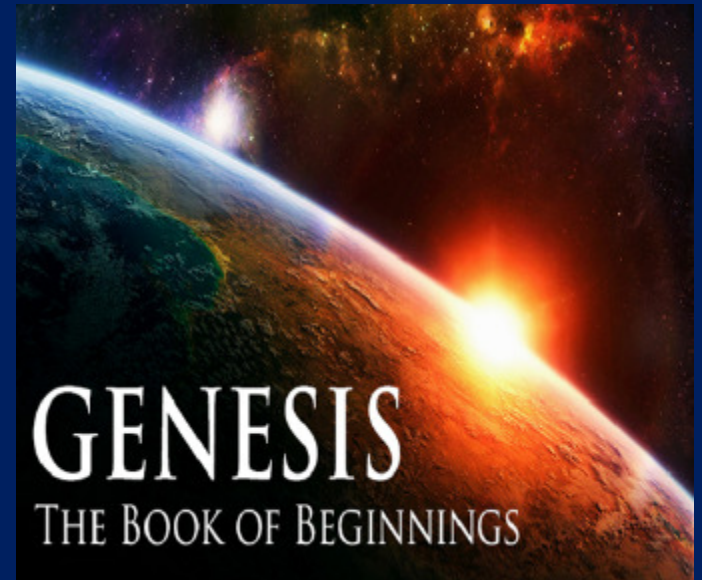

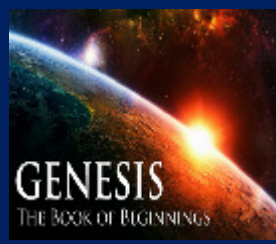

Geographical Distribution Of The Sons Of Noah

The three sons of Noah migrated to different areas. The Semites occupied the Tigris–Euphrates valley and most of Arabia; the Japhethites moved north, around the Black Sea, and even west to Spain; the Hamites went south into lower Asia Minor, coastal Syria and Palestine, and the Red Sea coast of Arabia, but principally into Africa.
