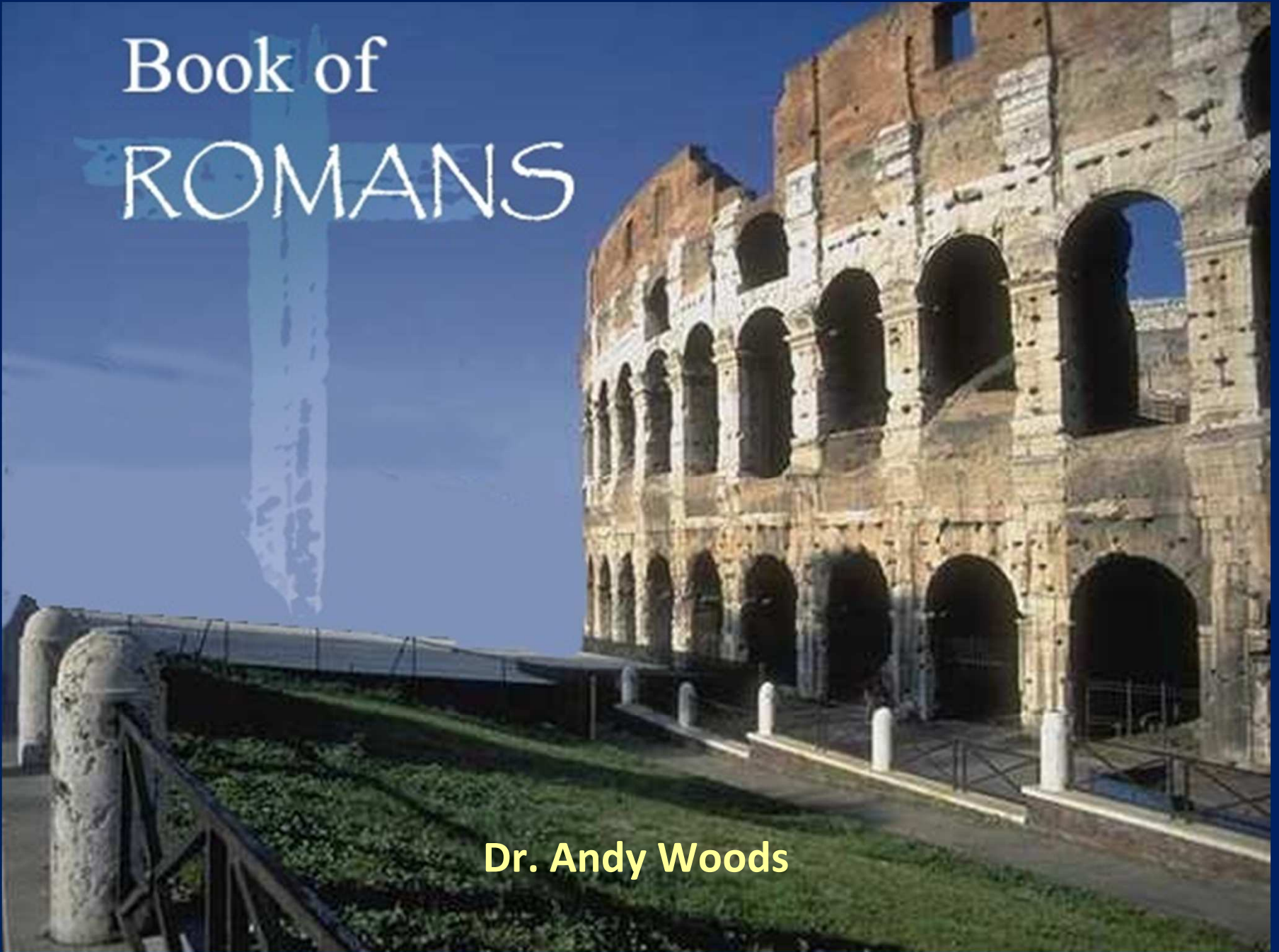
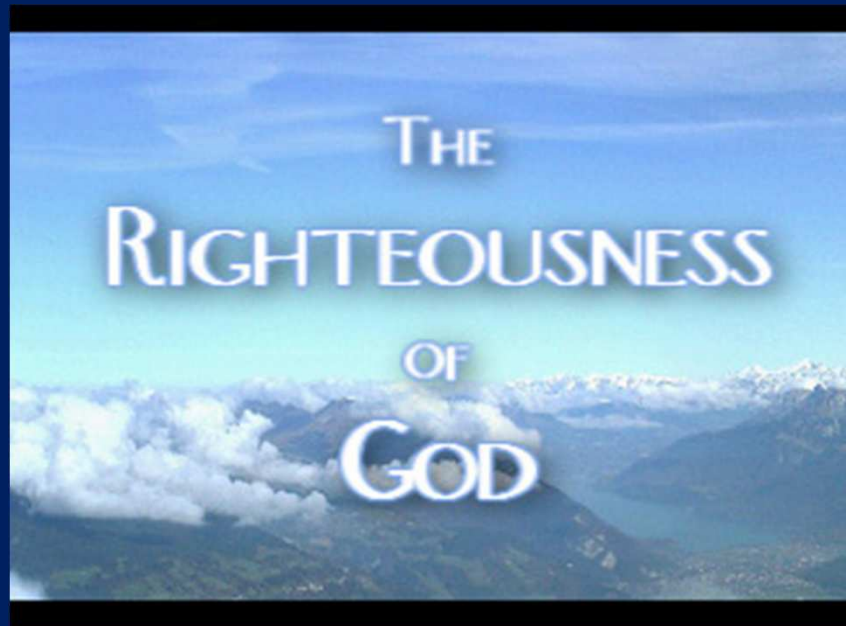

Saved from sin's:	Penalty	Power	Presence
Scripture	Eph 2:8-9; Titus 3:5	Philip 2:12	Rom 5:10

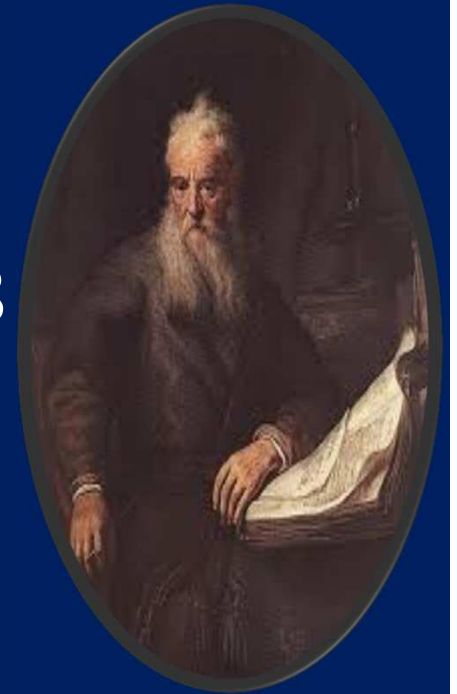
Believer's Relationship to Sin (Rom 6)

6:15-23

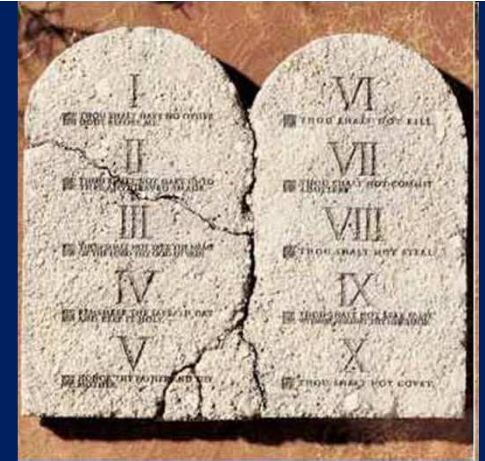


Sanctification (6–8)

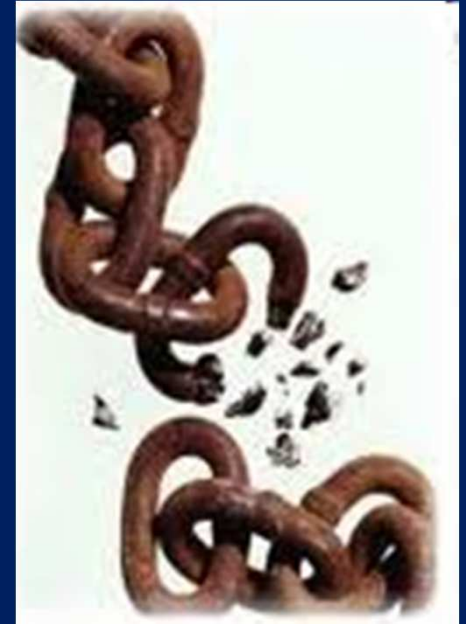

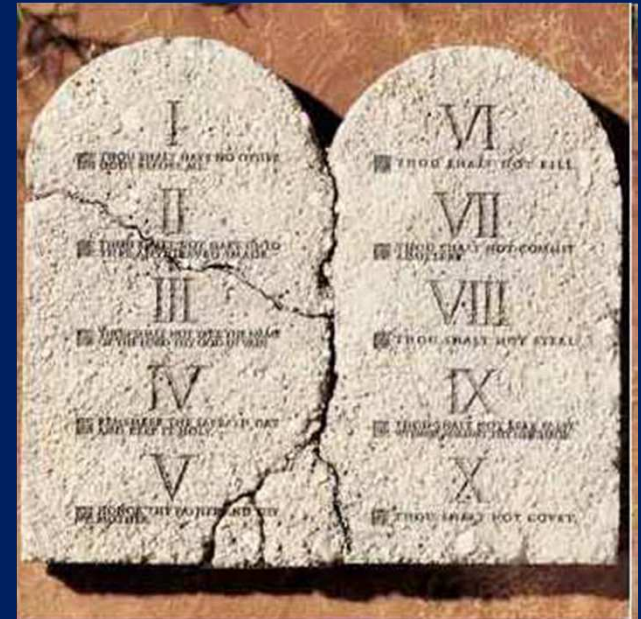
